



DRIVING DIRECTIONS: THE UNIVERSITY HEIGHTS CENTER

University Heights Center is a LARGE, beige schoolhouse located at the intersection of NE 50th Street between Brooklyn Avenue NE and University Way NE in the heart of Seattle's University District.

From Interstate 5 South:

Take exit 169 – NE 50th Street/ Seattle Pacific Univ.
Stay straight on ramp – to go onto 5th Avenue NE
Turn Left at light on NE 50th Street, Heading East
Continue on NE 50th Street approx. 0.75 mile

- To North Parking Lot:
Turn Left at Brooklyn Avenue NE
Turn into the North parking entrance mid block, just after the bus stop.
Continue to the North End of the Lot for Parking.
- To South Parking Lot:
Turn Left at University Way NE
Turn Left into South Lot directly after turning onto University Way.

Please do not park on the brick or obstruct parking traffic pathways. Thank You.

From Interstate 5 North:

Take exit 169 – NE 50th Street/ Seattle Pacific Univ.
Stay straight on ramp – to go onto 7th Avenue NE
Turn Right at light on NE 50th Street, Heading East
Continue on NE 50th approx. 0.75 mile

- To North Parking Lot:
Turn Left at Brooklyn Avenue NE
Turn into the North parking entrance mid block, just after the bus stop.
Continue to the North End of the Lot for Parking.
- To South Parking Lot:
Turn Left at University Way NE
Turn Left into South Lot directly after turning onto University Way NE.

Please do not park on the brick, drop/off or stop in the carriage drive or obstruct parking traffic pathways.

Parking Rules:

University Heights Parking is available for building tenants, visitors, staff and affiliates of the building first and foremost. There are 160 available parking spaces on UHCCA grounds. Parking is limited / restricted during Farmers Market season and during special events. All Building visitors parking in UHCCA lots must obtain a VALID parking permit from their [contact in the building](#) or at the [UHCCA office](#). All visitors must check with the building office or tenant contact in the building to verify current parking rules. All non-permitted vehicles may be subject to possible ticketing and towing at the owner's expense.

Monday – Friday 8:00am – 9:55pm, building Visitor Parking is available in the WEST SIDE of the SOUTH LOT ONLY. If there are no spots available then we are full. The UHCCA North Lot is closed for tenant and UHCCA usage only during these hours. All employees, staff for events must park their vehicles in this area only. You must place a pass in your vehicle or check with our offices if you are parking longer than one hour. If you park in the East side of the South Lot, you are subject to towing. We are not responsible for any vehicles left in the East side of the south lot. Do not park on this side of the property. You must remove your vehicle by 10pm Friday from this lot to avoid towing.

Saturdays, 7am – 3:30pm parking is limited, in the North Lot and is reserved for building tenants, building employees and Saturday Program staff. No parking is allowed in the North Lot unless designated by the parking attendant. Please check with the parking attendant during these hours. If there is no parking attendant, parking may be available in non-reserved or unmarked spots only. No Farmer's Market Parking allowed.

General Parking Times:

Please verify public parking times with our office or via the sign posted at our South entrance.

The South Lot is open to the general public; Mon – Fri: 6:00pm – 10:00pm, & Sat after 5:00pm, and Sun after 1:00pm. All vehicles must leave the property at 10pm. No overnight parking allowed. Any vehicles left overnight will be towed.
